



UMOfx 2017 New Year Lucky Draw Terms and Conditions (December, 2016)

1. The UMOfx 2017 New Year Lucky Draw (“Contest”) will run from 01/12/2016 to 01/03/2017 (“Contest Period”). United Market Oracle Limited (“UMOfx”) reserves the rights to shorten or extend the Contest Period without prior notice. All entries received outside the Contest Period shall automatically be deemed as disqualified.
2. The Contest is open to all UMOfx’s Clients and eligible to all types of live trading accounts.
3. How to participate:-
 - a. Deposit at minimum 100USD in single transaction to entitle for one (1) Ticket.
